#### MEET UP WITH TABLE TENNIS ENGLAND CHAIR SANDRA DEATON

#### WHO PARTICIPATED?

The meet up took place on Wednesday 09th December 2015 at The Village Hotel and Leisure Complex, Aylesford, near Maidstone. It was attended by representatives from the KCTTA (Neil Le Milliere, Roger Harris), Bromley (Carol Homewood and Stan Matthews), Canterbury (Clive Hollingsbee and John Wickings), Isle of Thanet (Ian Mileham and Simon Hillier), Sittingbourne (Colin Wiles and John Carr), Kent Guest (Barry Chapman). There were three late withdrawals (Maidstone, Sevenoaks and KCTTA). Some Leagues declined the invitation (Ashford, Folkestone, West Kent), others did not respond to the invitation (Dover, Gravesend, Medway). WHAT WAS THE AIM?

Whilst it was intended to keep it informal, we wanted to ensure it was a constructive exercise. Everyone has pretty much the same goal, it is a question of how we may all work together to effectively realise the aims to increase participation, have a democratic organisation relating to its membership, making it easier to get more coaches into local TT, deal with lack of volunteers. My particular reason for arranging the meet up was the feeling it is vital the leaders of Table Tennis England meet face to face with its membership, so as there is proper two way dialogue. It was apparently the first time this had been done with a County. WHAT DID IT ACHIEVE?

The members certainly made their points on a number of key issues to Sandra. They were acknowledged, some changes were promised as in process of being made (such as making it both easier and less cost to attract more coaches, membership future costs structure and liaison with members). Sandra praised the efforts being made by various members who attended for their efforts in promoting grass roots TT across the County (among them development leagues, new multi table venue, young player coaching and development).

In itself it may be seen as one step in the right direction but there is a long way to go before the gap between Table Tennis England and its membership is bridged. Those at the meet up were strongly of the view that this is best done by all members have direct path to Table Tennis England on matters affecting local TT, this was indeed Sandra's view.

Footnote: you will have seen the start of a new liaison process whereby National Councillors are going to be a conduit between the membership in their County and Table Tennis England. The National Council is now a consultation body and hold periodic meetings with Table Tennis England. This liaison route with members was recently recommended by a majority vote of the National Council. Hopefully members will engage in this process as the more grass root views that reach the ears of the Table Tennis England Executive the greater the chance there will be of seeing changes you would like made. It is an opportunity to help enhance your sport.

#### KENT LEAGUE ADMINISTRATION

We have all been very grateful to David Cue for organising our Kent League for the last sixteen years. As you know he is standing down at the end of this season. I am sure you will show your appreciation at our AGM.

David has arranged for the Kent League to continue with myself as Organiser next season. Over recent years we have had comments about the way players would prefer to have the administration operated with greater use of the electronic media. If I am elected to the post then I would seek to carry out those wishes, starting this coming season. This will require quite a bit of preparatory work in the coming months in order to be ready.

#### INVICTA DL.

As a result of the above we have held back from bringing in the proposed Invicta Development League. It made sense to integrate its arrangements in with the Kent League, thus bringing this new initiative into being next season. We hope there is interest as it should be a good progression path in the County for developing players.

### KENT COUNTY ROLES DESCRIPTIONS

These follow below for all roles involved in the County Infrastructure.

#### **NewsLINK**

Issued on behalf of KCTTA Roger Harris Secretary.

<sup>\*</sup> NB There are no Regional Finals for the Junior Events this is a stand alone competition.

The KCTTA like most organisations needs new Officers every so often. One of the first questions asked by anyone interested in taking up a role is what does it entail. So we have set out role descriptions that form the Kent County Table Tennis Association Management Committee and its related roles. Election to these roles is at the AGM or a SGM, except if stated otherwise.



#### CHAIR

Head of Management Committee.

Responsible for good running of the Association, includes inter alia;

- conducts KCTTA Annual General (unless President takes up option of doing so),
   Management and other meetings called by the Secretary, in manner where procedures are fair, reasonable and constructive
- ensures as far as reasonably practicable adherence to the KCTTA Constitution, Rules and otherwise within the framework of the declared aims and objectives of the Association.
- speaks on behalf of the Association at meetings with third parties on relevant matters.

#### **SECRETARY**

Member of the Management Committee.

Responsible for formal administration of the KCTTA including inter alia;

- the KCTTA administrative point of contact with Table Tennis England and our Affiliated Leagues and any Directly Affiliated Clubs
- receiving, distributing and responding to correspondence from these bodies
- general correspondence in respect of issues relating to the operation of the Association, including to our President, Life Vice Presidents and other persons external to the Association
- arranges the Annual General Meeting, Management Committee meetings in respect of venues, provision of agenda and related meeting documents, preparation and distribution of meeting records (minutes)
- administrator and keeper on behalf of KCTTA of its Constitution and Rules
- notifies Affiliated Leagues and relevant persons of the Management Committee and AGM or other meeting decisions relating to specific issues
- refers necessary disciplinary issues to the Disciplinary Sub Committee Chair and advises of its decisions.

#### TREASURER

Member of the Management Committee.

Responsible for the finances of the KCTTA and includes inter alia:

- prepares the budget estimates
- receives incoming monies
- pays outgoing monies
- records all transactions

- maintains a financial statement
- puts in place cheque signatories or other requisite sign off procedures
- deals with our banks in regard to our accounts
- keeps adequate cash flow funds for such payments
- aids Auditor on AGM statement
- recommends Affiliation Fee rates to Management Committee for their decision.

#### VICE CHAIR

Member of the Management Committee.

- stands in for the Chair in their absence
- assists Chair in the running of the Association.

#### NATIONAL COUNCILLOR

Member of the Management Committee.

Nominations of a Table Tennis England member may come from any Affiliated league. Elected by the KCTTA Management Committee.

Member of the Table Tennis England National Council.

Responsible for;

- acting as link for representing the views of the KCTTA Management Committee to Table Tennis England
- attend at and vote on National Council propositions as the elected member sees fit
- there is now a move for the National Councillor to be a conduit for feeding the views of Table Tennis England members across the County back to the National Council.

#### DEPUTY NATIONAL COUNCILLOR

Member of the Management Committee.

Elected by the KCTTA Management Committee.

Responsible for;

- aiding the National Councillor in their duties
- standing in for the National Councillor on occasions of their absence.

#### KENT LEAGUE ORGANISER

Member of the Management Committee.

Responsible for overall organisation of The Kent League and includes inter alia;

- ensures Competition rules are up to date
- ensures all Competition documentation is in place
- sends out and receives responses to entry invitations
- ensures all fixtures are arranged and fulfilled in compliance with Competition rules
- ensures all results are received and league tables are maintained
- ensures trophies are provided to respective winners.

#### **UMPIRES SECRETARY**

Member of the Management Committee.

Responsible for overall organisation of all Kent Umpire activities:

- maintains register of active umpires living in Kent
- promotes new umpires into gaining Table Tennis England accreditation

- provides umpires for County Teams, County Closed Tournament and competitions.

#### COUNTY TEAMS ADMINISTRATOR

Member of the Management Committee.

Responsible for overall organisation of Kent County Teams working in conjunction with County Team Coordinators (Junior/Senior/Veteran/Over 60) and includes inter alia;

- receives and sends in the required entry forms and payments for County teams
- receives and distributes County Team handbooks, score cards, match balls
- maintains log of all County shirts issued to teams and holds residual stock of shirts
- ensures County Team Coordinators work to the County Championship Regulations
- reports to the Kent Management Committee on all County Team matters.

#### CLOSED TOURNAMENT ORGANISER

Member of the Management Committee.

Elected by the KCTTA Management Committee.

Responsible for overall organisation of Kent Closed Tournament and includes inter alia;

- ensures Competition rules are up to date
- ensures all Competition documentation is in place
- ensures the Competition event scheduling is carried out
- ensures the Competition entries are sent out and received and conducts the draws
- ensures all the Competition facilities are in place
- ensures Competition is completed and conducted in good order
- ensures all Competition trophies are in place and presented.

#### COACHING OFFICER

Member of the Management Committee.

Responsible for overall organisation of Kent Coaching activities and includes inter alia;

- maintain register of qualified Coaches in the County
- promote and encourage Coaches to gain UKCC qualifications
- aid Coaches around the County to set up sessions for all standards of play.

#### **DEVELOPMENT OFFICER**

Member of the Management Committee.

Responsible for overall organisation of Kent Development and includes inter alia;

- maintains register of Kent grant aided development schemes and their progress
- promotes all Leagues, Clubs and others to increase participation at all levels
- works in liaison with Table Tennis England Regional Development Officer.

#### **COMMITTEE MEMBERS**

Member of the Management Committee.

Responsible for assisting the Officers in their administration of the Association activities and its rule book, attending any Management Committee meetings called by the Secretary, or participating in matters by email or the alike to resolve and progress issues. A Committee member holds no other KCTTA post.

#### **AUDITOR**

This is an elected but Ex Officio post, having no role on the Management Committee. The auditor receives, reviews and checks the Treasurers's statement of accounts and supporting documents to ensure good practice has been followed. The Auditor may make recommendations that the Association might follow to ensure transparency and signs the Financial Statement as a true record for presentation to the AGM.

#### DISCIPLINARY SUB COMMITTEE

Elected by the KCTTA Management Committee.

There are are five members, comprising of a Chair, reporting to the Kent Management Committee, with four members. They are not normally members of the Management Committee. They receive and deal with disciplinary matters presented to them by the KCTTA Secretary.
